



69TH ANNUAL MEETING OF MEMBERS PRIZES TERMS & CONDITIONS

For the purposes of these Terms and Conditions, “Prize” or “Prizes” refers to the following items: a Toro MyRide Zero Turn Mower (valued at approximately \$5,000), a Samsung 65” Class The Frame Pro Smart TV (valued at approximately \$1,898), and a Traeger Woodridge Pro Wood Pellet Grill and Smoker (valued at approximately \$1,149). **Prizes are non-transferable, non-refundable, and non-negotiable.** Should the Prize become unavailable, FOCUS Broadband reserves the right, at its sole discretion, to substitute any Prize with a prize of equal or greater value or make other arrangements with a Prize winner as deemed appropriate. This Prize is void where prohibited by law.

Eligibility

Members must register for FOCUS Broadband’s Annual Meeting of Members to be entered into a randomized drawing to receive one (1) of the aforementioned three (3) Prizes. By registering, participants are automatically entered into the drawing and agree to be bound by these Terms and Conditions.

The drawing is open only to current FOCUS Broadband Members. Limit one (1) entry per membership. Current and former employees and members of their households, as well as current or former Board of Directors, are not eligible to participate. Members must be 18 or older to be eligible to participate.

By registering, members authorize FOCUS Broadband to contact them using the phone number or email address associated with their account if selected as a Prize winner.

Prize Winners

The drawing will take place following the close of the registration and voting period. Winners will be selected at random. The odds of winning the prize will depend on the total number of eligible entries received during the voting and registration process.

Prize Claim
